If the fetus is a person, why is the woman not a principal or an accomplice? Further, the penalty for criminal abortion... is significantly less than the... penalty for murder... If the fetus is a person, may the penalties be different?*" Such prolife hypocrisy and partiality seems to have been the opportunity for our Supreme Court to deal lawlessly in *Roe* in not justly recognizing the personhood of our unborn children. In turn, we ignored this lawlessness for 50 years in pursuit of our own lawless regulations of how and when we **may** commit unborn child murder, ourselves justifying our unjust court. Instead of criminalizing unborn child murder as we ought, we have criminalized the violation of our lawless regulations instead. Our allowing our unjust court to judge itself in overturning *Roe* has **not** resolved this.

*"A man (or woman) that doeth violence to the blood of any person shall flee to the pit; let no man stay (support) him." (Proverbs 28:17)*

We must repent of not keeping the way of the Lord **now**. Please repent with me. Plead with our public servants to repent.

Unborn child murder, "abortion," must be abolished, immediately and totally, in all our jurisdictions of the U.S.
