Dear Governor DeWine

I would like to volunteer myself for your consideration when you appoint the next United States senator from Ohio. This appointment is certainly a serious matter for both Ohio and the nation and a very unique and historic opportunity for you.

Of greatest concern to us all should be that all human beings in all jurisdictions of the United States are to be preserved the precious rights of life, liberty and the pursuit of happiness. This means equal protection of law whereby all three branches of state and federal government must look benignly at any person's attempt to seek redress of wrongs to his or her immortal rights. This especially means we must recognize all of our preborn children with our laws, abolish unjust and penalty-free exceptions and regulations for taking their lives, and preserve them nothing less than protection that is equal to what we preserve for ourselves. This inequality of protection of our preborn children is interrelated to domestic violence, crime, an insecure border, and illegal immigration. This leads to ruinous public spending and debt and a weak and turbulent economy which leads to more inequality of protection of our preborn children.

This means states like Ohio must dutifully support the Fourteenth Amendment to the United States Constitution and no longer deny equal protection of law to our preborn children. Under the cover of United States Supreme Court rulings (*Roe*, *Casey*, *Dobbs*), amendments to several state constitutions (including Ohio's), and many state or federal laws, all contrary to the Fourteenth Amendment, the people of Ohio and the United States have perverted the administration of justice for now over 50 years and it stands as the greatest and costliest national security threat for generations to come. The people of Ohio and the United States must preserve the equal protection of law to our preborn children without delay.



Someone must lead new thinking in discovery, definition, debate, deliberation, and decision without being already colored by politics as usual or already colored as both party and judge to the controversy. This means you may consider the appointment of the next United States senator from Ohio a very unique and historic opportunity for yourself, for Ohio, and for our nation to fulfill what it is to preserve equal protection of law.

I have already conducted three single-issue write-in campaigns for an Ohio seat in the United States Senate in 2018, 2022, and 2024 earning votes in at least 77 of Ohio's 88 counties while directly corresponding with 291 of Ohio's legislative officeholders and candidates, delivering testimony at legislative committee hearing, and engaging the Ohio and national public through specific content developed for internet & social media, radio, newspaper, telephone, billboard, church & town hall, interview, and voter guide. I also played an active role in addressing exigent concerns related to COVID-19 through legislative, executive, and judicial means. All of this was by personal investment and commitment in support and defense of our laws in addition to the course of my normal duties as a United States military reserve officer wherein I have continued to serve for nearly 20 years as uniformed consultancy on matters of technology critical to our national aerospace and defense concerns.

These efforts and results demonstrate my personal conviction that inaction towards preservation of equal protection of law to our preborn children has an immense cost. These efforts and results demonstrate my personal commitment to learn and lead diversity of thought in major, complex, and serious interrelated contemporary issues. Discerning Ohioans are ready to consider me for the same in a very unique and historic opportunity. I encourage you to seek their thoughts and consensus as you consider me for this appointment. I would very much like to volunteer, to meet with you for an interview, and to humbly serve as the next United States senator from Ohio.
